#### REFORMS TO THE NATIONAL PLANNING POLICY FRAMEWORK (NPPF)



The Department for Levelling Up, Housing, and Communities is seeking views on <u>reforms to the NPPF</u>. The deadline for responses is 2<sup>nd</sup> March 2023. The <u>Consultation</u> poses 58 specific questions on potential changes to planning policy, including questions on

affordable and community led housing, neighbourhood planning and the role of design and beauty on place making.

# SUFFERING FROM THE RURAL COST OF LIVING? MAKE YOUR THOUGHTS KNOWN



The Rural Services Network (RSN) in partnership with the Citizens Advice Rural Issues Group (CARIG) has launched a Rural Cost of Living Household Survey. Independent research commissioned by the RSN in summer last year shows rural areas are suffering more acutely from the cost of living crisis compared to urban areas. To lend more

weight to the argument for more funding for rural areas the RSN is calling on as many rural residents as possible to complete a Rural Cost of Living Household Survey. The purpose of the survey is to understand more about rural household budgets at, what is, a very difficult time for many. Research has shown that those living in rural areas face extra costs and the RSN and CARIG now want to explore the impacts for households. #### **DaRT 1 AND 2 CONSULTATION – UTTLESFORD**



Essex County Council ECC are proposing to re-design the current DaRT services 1 and 2 to create a new single service numbered 299, which will not duplicate other services. The ECC states for most people their journey will not change. But for some, this could mean changes to how they make their journey and that is what this consultation covers. ## A Coronation Big Lunch on Sunday 7th May

In a nationwide act of celebration and friendship, communities will be invited to share lunch together in their streets, parks, gardens and community spaces to mark the historic occasion of the Coronation. The Big Lunch team, supported by the Eden Project, will provide downloadable resources via <a href="this link">this link</a> for those wishing to plan a Big Lunch event. It may also be useful to note that the Government is encouraging street parties and has written to local authorities to ask them to support local residents who want to organise events for their neighbours.

## The Big Help Out on Monday 8th May

The *Together Coalition* would be delighted to highlight the positive impact that volunteering has on communities across the United Kingdom.

Recalling His Majesty's lifelong dedication to public service, supported by The Queen Consort and other Members of The Royal Family, it is hoped the initiative will bring communities together in volunteering initiatives and create a lasting legacy from the Coronation weekend.

A volunteering awards scheme will shortly be launched by His Majesty in partnership with the Royal Voluntary Service. The initiative will focus on the contribution made by volunteers of all ages across the country from a wide range of community groups and charities.

#### **Emblem**

Following tradition for major national Royal events, an official Coronation Emblem will soon be launched. The Emblem will be available free of charge for use by communities, businesses and other organisations or individuals who wish to use it for Coronation-related events and materials.

#### **Ideas**

His Majesty's Lord Lieutenant of Essex, Mrs Jennifer Tolhurst, the King's personal representative in the county has requested your help with support and imaginative local ideas. This would be greatly appreciated as we all work together on this historic series of events. In particular, to focus on the overall ambition to promote the themes of youth, community, diversity and sustainability.

#### **FUNDING OPPORTUNITIES**

The National Lottery Community Fund is supporting communities across the UK to come together to mark the Coronation. Funding of up to £10,000 is available for Coronation-related events and activities via the National Lottery Awards for All programme.

The programme does not have a deadline but it can take up to twelve weeks from the date of application submission for successful groups to receive funding. In other words, applications for events around the Coronation weekend would need to be made by mid-February. The funding criteria terms and conditions can be found here.



The National Lottery Heritage Fund will celebrate the Coronation by providing new opportunities for younger people to engage with heritage, the natural environment and landscapes, and create a new cohort of traineeships in environmental

organisations for young people from diverse and economically disadvantaged backgrounds.

The Coronation programme will build on the Heritage Fund's Platinum Jubilee programme from 2022, with a £7 million commitment to help communities across the UK reconnect with nature and support young people in taking their first steps toward a career in natural heritage. #### ESSEX RECYCLING CENTRE BOOKING SYSTEM ANNOUNCED



From Monday 13<sup>th</sup> March 2023, residents visiting Essex County Council (ECC) recycling centres will need to book in advance. A booking system will be trialled for all vehicles visiting ECC recycling centres to help manage waiting times, reduce congestion, and improve the customer experience. The booking process has already been trialled for all vehicles using Rayleigh Recycling Centre, and also for large vehicles using

the nine van-friendly sites. Both trials have been effective in smoothing the pattern of demand across operating hours and reducing queues and congestion both in and around the sites. Residents will be able to book their slots in advance from Monday 27th February. Site users visiting by foot do not need to book a slot. Blue Badge holders do not need to book a slot.
