

RURAL CRIME STRATEGY LAUNCH



Tackling crimes within rural communities and supporting vulnerable people will be top priorities in the new Rural Crime Strategy 2023-2026. Police, Fire and Crime Commissioner, Roger Hirst, together with representatives of Essex Police and the Essex Rural Partnership outlined the new strategy at a public event held at Layer Marney Tower on 10th March.

The previous strategy, which completed its four-year term in 2021 saw a significant reduction in rural crimes. Unauthorised encampments were reduced by more than 70 per cent, hare coursing saw a reduction of 10 per cent and the theft of large machinery by 36 per cent.

Following feedback from rural communities, the new strategy will go even further, with a stronger focus on tackling all crimes within rural communities, supporting community empowerment, protecting vulnerable and isolated rural communities, and supporting victims of crime.

Police, Fire and Crime Commissioner Roger Hirst said: “In Essex, we have made protecting rural and isolated areas a key priority in the Police and Crime Plan 2021 – 2024, with the objective to work with rural communities to help them build greater resilience and make them more safe and secure for all.

RCCE Executive Director, Nick Shuttleworth, speaking for the Essex Rural Partnership said:

“Essex Rural Partnership brings together a wide range of organisations concerned with the future of the county’s rural areas. Rural crime is an important issue for the Partnership, and we are committed to supporting Essex Police and the Police Fire and Crime Commissioner in taking forward this refreshed strategy.”

SCHOOL ORGANISATION AND PLACE PLANNING



The Essex School Organisation Service (ESOS) have recently published a new ‘Ten Year Plan’. An annual publication with the current edition covering the period up to and including the 2032/33 academic year. The document contains the core evidence that is used when asking developers for section 106 contributions towards school places and demonstrates a record in both delivering new school places and the commitment to meeting the future needs of a community.

There are four main sections:

- An overview of the Service and how school places are planned
- Pupil forecasts for each area using groups of schools agreed with the Department for Education
- Details of potential new school and expansion projects
- A list of projects, for each district, that have been completed in recent years

The ESOS state that over the past few years, forecasts in the Ten Year Plan have proved robust, and have supported the collection of around £18m per year from developers for school places in Essex.

As the document demonstrates, the Essex School Organisation Service have used this money, in conjunction with other funding, to deliver around one hundred projects during the last seven years. FUNDING OPPORTUNITIES



The Prince's Countryside Fund (PCF) is inviting applications for grants of up to £25,000 from community projects across the UK, with up to £250,000 available. The PCF is interested in projects that will make a difference in rural communities across the UK and clearly demonstrate the need within the community. Applications are encouraged from all parts of the UK.

Keith Halstead, Executive Director of The Prince's Countryside Fund said: "The PCF's grant programme enables rural communities to become more self-sufficient by funding community-led solutions. With thanks to Waitrose and players of People's Postcode Lottery, the PCF aims to invest at least £500,000 each year through our rural grant programmes to make projects happen, particularly in hamlets, villages, and small towns."

APPLY FOR ENERGY BILL SUPPORT FOR NON-DOMESTIC PROPERTIES



Who can apply?

This scheme provides support for all UK non-domestic consumers using alternative fuels such as kerosene for energy, that are not on the gas grid. This includes commercial businesses, voluntary sector organisations including charities and community interest companies and public sector organisations such

as schools, hospitals and care homes. The fixed payment of £150 to UK non-domestic consumers who are off the gas grid and use alternative fuels are eligible for this payment and some will have already received it automatically as a credit on their electricity bills. Properties not connected to the electricity grid will not have received £150 automatically and will need to apply through the online portal. Higher users of kerosene, defined as over 10,000 litres per year, will be eligible to apply for an additional payment based on the amount of Kerosene they use.

If you are not connected to the electricity grid, you will need to apply for the £150 fixed payment.

If you use more than 10,000 litres Kerosene per year you may be eligible for the additional payment and you will need to apply and provide evidence to support your claim.
