UNLOCKING THE MAGIC INGREDIENT



In September 2023, English Rural published some research by UCL about the unlocking potential of Rural Exception Sites (RES). These small bespoke sites are an exception to planning policy and provide affordable housing prioritised for local people in perpetuity. Full details and link to the please <u>click here</u>.

To achieve a rural exception site in your parish you need to establish if your parish needs one. It is not always obvious that your parish has a local housing need so the first step would be to undertake a **Housing Needs Survey**.

Lavenham Community Land Trust, in Suffolk, is seeking to appoint a new professional trustee to join their experienced board and to help steer them forward at a very exciting time.

They have already delivered a new build scheme, Peek Close, which created 18 homes for rent or shared ownership in Lavenham and are seeking to deliver similar developments in the near future.

In 2022 they sponsored a Housing Needs Survey to provide a strong evidence base for their way forward and enjoy a good working relationship with the local authority Babergh District Council. Trustees with special skill sets will help to innovate and lead the delivery of LCLT activities alongside our volunteers. Meetings are held in Lavenham around 6 times a year.

The Essex Waste Partnership (EWP) has set out how they plan to manage waste in Essex over the next 30 years in a draft strategy. Now, they want you to tell them what you think about it. What we throw away each day comes at a cost, not just for us but for the environment too. So, we all need to rethink waste. This means reducing what we buy, reusing items and recycling them when they are no longer needed.

The draft strategy, which has been produced by the Essex Waste Partnership, is deliberately ambitious but achievable. It reflects a joint commitment from councils in Essex to reducing the impact of waste management on climate change. The proposals will also help to conserve resources and save money in the long-term. This money could then be used elsewhere.

There is lots of positive work happening to reduce waste in Essex already and the EWP want to build on this, by working together and making small changes, we will see a big difference.


